WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment, in the Manila Standard, a newspaper of general nationwide circulation on 31 May 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is ₽ 5.000.000.00:

WHEREAS, in response to the said advertisement, two (2) prospective bidders secured the Bid Documents in the amount of ₽ 5,000.00, namely:

- 1. Trends and Technologies, Incorporated
- 2. Infostorage Corporation

WHEREAS, during the opening of bids on 22 June 2018 at 10:00 a.m., Infostorage Corp. was declared "passing" with the requirements of the First Envelope, Trends and Technologies, Inc. was declared "failed" but no request for reconsideration was filed within the prescribed deadline for filing thereof;

WHEREAS, the Financial Proposal of Infostorage Corp. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
