WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of Multi-Site Remote Surveillance Monitoring Equipment and Services (Phase III), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 02 June 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 480,000,000.00**;

WHEREAS, in response to the said advertisement, only Kit Properties/ Beyondsight Philippines, Inc./iPointeast Inc./JV secured the Bid Documents in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 25 June 2021 at 10:00 a.m., Kit Properties /Beyondsight Philippines, Inc./iPointeast Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Kit Properties /Beyondsight Philippines, Inc./iPointeast Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KIT PROPERTIES/ BEYONDSIGHT PHILIPPINES,INC./IPOINTEAST INC./JV** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery, Installation and Commissioning of Multi-Site Remote Surveillance Monitoring Equipment and Services (Phase III), in the amount of **FOUR HUNDRED SEVENTY EIGHT MILLION FIVE HUNDRED THOUSAND PESOS (PHP 478,500,000.00)**, inclusive of taxes, to the said bidder.


