**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROVISION AND DELIVERY OF CY 2023 PPA OFFICIAL UNIFORMS
ASD-142-2023**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Provision and Delivery of CY 2023 PPA Official Uniforms, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 10 June 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,593,800.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 10,000.00 and submitted their Technical and Financial Proposals, namely;

1. Dante's Executive Menswear & Bag Accessories
2. La Marina Enterprises Inc.

WHEREAS, during the opening of bids on 04 July 2023 at 10:00 a.m., Dante's Executive Menswear & Bag Accessories was declared "failed" for failure to comply with the color of the font for the agency name while La Marina Enterprises Inc. was declared "automatically disqualified" considering that the submitted Second Envelopes are not book bound and without index tabs, as required under Clause 15 of the Bid Data Sheet of the Bidding Documents, which states that "xxx All bid documents shall be book bound with hard cover and properly labelled with index tabs";

WHEREAS, Dante's Executive Menswear & Bag Accessories signified its intention to file a request for reconsideration, however, on 06 July 2023, it submitted a letter manifesting that they will no longer file a motion for reconsideration for the project;

WHEREAS, considering that the two (2) bidders were declared "failed," the bidding was declared a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx


b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Provision and Delivery of CY 2023 PPA Official Uniforms, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.



This has reference to the Opening of Bids for the Provision and Delivery of Cy 2023 PPA Official Uniforms on 04 July 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible xxx xxx xxx." The two (2) bidders, Dante's Executive Menswear & Bag Accessories and La Marina Enterprises were both declared "failed."

In view thereof, we are submitting herewith BAC-PGCS Resolution 054-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
