Award of Contract for the
**PROCUREMENT OF TECHNICAL SUPPORT SERVICES FOR
THE PHILIPPINE PORTS AUTHORITY'S CORE APPLICATION SYSTEMS**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application Systems, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 09 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 13,000,000.00**;

WHEREAS, in response thereto, only Diversified Infrastructure and Architectural Dev't. Works Corp. secured and submitted its Eligibility Documents within the prescribed deadline for submission thereof;

WHEREAS, after the Eligibility Screening conducted on 17 May 2019, Diversified Infrastructure and Architectural Dev't. Works Corp. was declared eligible to bid for the project;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting of consultants should be conducted;

WHEREAS, considering that Diversified Infrastructure and Architectural Dev't. Works Corp. was declared eligible to bid for the project and the required number of shortlisted consultants as advertised should be not more than five (5), Diversified Infrastructure and Architectural Dev't. Works Corp. was automatically considered as shortlisted, pursuant to Head Office-Procurement of Goods and Consultancy Services (PGCS) Resolution No. CON 052-2019 Series of 2019, dated 17 May 2019;

WHEREAS, pursuant to Section 24.5.4 of the 2016 Revised IRR of R.A 9184, "The BAC shall recommend the short list of consultants to the Head of the Procuring Entity for consideration and approval. xxx xxx xxx."

WHEREAS during the opening of the Technical Proposal (First Envelope) conducted on 11 June 2019, Diversified Infrastructure and Architectural Dev't. Works Corp. passed the requirements of the First Envelope;

WHEREAS, detailed evaluation of the Technical Proposal was conducted on 20 June 2019, using the criteria specified in the Bidding Documents, and the said evaluation resulted in the following:

WHEREAS, after the opening and evaluation by the BAC of the Financial Proposal (Second Envelope) of Diversified Infrastructure and Architectural Dev't. Works Corp., the following total rating, taking into consideration the technical and financial rating, were arrived at, as follows:

WHEREAS, Bid Evaluation was conducted on 01 July 2019 to determine arithmetical or computational errors on the bid proposal of Diversified Infrastructure and Architectural Dev't. Works Corp., and the Bid Evaluation Report which was approved by the BAC on 02 July 2019, showed discrepancy on the bid proposal of Diversified Infrastructure and Architectural Dev't. Works Corp., as shown in the following table;

WHEREAS, Diversified Infrastructure and Architectural Dev't. Works Corp. was declared as the Single Rated Bidder in the amount of ₱ 12,991,148.62, pursuant to Section 34.4 of the Revised IRR of R.A. 9184;

WHEREAS, Post-qualification was conducted on 04 July 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Diversified Infrastructure and Architectural Dev't. Works Corp. and in the Post-Qualification Report, approved by the BAC on 12 July 2019, Diversified Infrastructure and Architectural Dev't. Works Corp. was declared as the Single Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **DIVERSIFIED INFRASTRUCTURE AND ARCHITECTURAL DEVELOPMENT WORKS CORPORATION** as the Single Rated and Responsive Bidder and to recommend the award of contract for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application Systems, in the amount of **TWELVE MILLION NINE HUNDRED NINETY ONE THOUSAND ONE HUNDRED FORTY EIGHT AND 62/100 PESOS (₱ 12,991,148.62)**, inclusive of taxes, to the said bidder.


