**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
PROCUREMENT OF ADMINISTRATIVE SUPPORT MANPOWER SERVICES FOR  
PPA PORT MANAGEMENT OFFICES AND PROJECTS (LUZON CLUSTER)  
BAC-PGCS-100-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster) in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 June 2021 continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 252,625,710.28**;

WHEREAS, in response to the said advertisement, only DBP Service Corporation secured the Bid Documents in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 08 July 2021 at 2:00 p.m., the lone bidder, DBP Service Corporation was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of DBP Service Corporation was opened and declared "passing" with the requirements of the Second Envelope and its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 15 July 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 16 July 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of DBP Service Corporation;

WHEREAS, however, DBP Service Corporation was declared "failed" for failure to conform to the prescribed Philhealth Premium Rate of 3.50% of monthly salary divided by 2, prescribed in Annex "A" of the Terms of Reference of the bidding documents;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that "all prospective bidders are declared ineligible."
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.


