Award of Contract
PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF ZAMBOANGA
BAC-PTMC-05-2020

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Port Terminal Management Contract (PTMC) for Port of Zamboanga in The Manila Times, PPA website and in conspicuous places in the PPA premises on 22 February 2021;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 2,489,340,006.85 exclusive of all taxes;

WHEREAS, in response to the said advertisement, one (1) bidder, the Joint Venture (JV) of Harbour Centre Port Holdings, Inc. (HCPHI) and Z.C. Integrated Port Services, Inc. (ZCIPSI), secured the Bid Documents in the amount of Php 150,000.00;

WHEREAS, during the Opening of Bids on 17 March 2021 at 10:00 a.m., the JV of HCPHI and ZCIPSI was declared "passed" in the requirements of the First Envelope;

WHEREAS, the Second Envelope of the JV of HCPHI and ZCIPSI was opened, with its Proposed Concession Fee read as follows:

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order No. 12-2018, and the Bid Evaluation Report was approved on 29 March 2021, declaring the JV of HCPHI and ZCIPSI at its Proposed Concession Fee of Two Billion Five Hundred Three Million Pesos (Php 2,503,000,000.00) exclusive of all taxes, as the Single Calculated Bidder;

WHEREAS, Post-Qualification was conducted on 8 April 2021 to determine compliance with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 14 April 2021, the proposal of the JV of HCPHI and ZCIPSI was declared as the Highest Responsive Bid;

NOW, THEREFORE, for an in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare the JV of HCPHI and ZCIPSI at its Proposed Concession Fee of Two Billion Five Hundred Three Million Pesos (Php 2,503,000,000.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for Port of Zamboanga.






