WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Body Worn Cameras (Phase II), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 14 June 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 170,000,000.00**;

WHEREAS, in response to the said advertisement, only Boston Home, Inc. secured the Bid Documents in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 06 July 2021 at 10:00 a.m., Boston Home, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Boston Home, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 12 July 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 13 June 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Boston Home, Inc.;

WHEREAS, Boston Home, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 168,680,000.00;

WHEREAS, post-qualification was conducted on 16 July 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home, Inc. and in the Post-Qualification Report, as approved by the BAC on 22 July 2021, Boston Home, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Body Worn Cameras (Phase II), in the amount of **ONE HUNDRED SIXTY EIGHT MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (PHP 168,680,000.00)**, inclusive of taxes, to the said bidder.


