WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Visayas Cluster), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 June 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 122,322,495.95**;

WHEREAS, in response to the said advertisement, only Temps and Staffers, Inc. secured the Bid Documents in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 09 July 2021 at 2:00 p.m., Temps and Staffers, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Temps and Staffers Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 15 July 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 16 July 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Temps and Staffers Inc.;

WHEREAS, Temps and Staffers Inc. was declared as the Single Calculated Bidder in the amount of ₱ 121,862,182.95;

WHEREAS, post-qualification was conducted on 21 July 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Temps and Staffers Inc. and in the Post-Qualification Report, as approved by the BAC on 28 July 2021, Temps and Staffers Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **TEMPS AND STAFFERS, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Visayas Cluster), in the amount of **ONE HUNDRED TWENTY ONE MILLION EIGHT HUNDRED SIXTY TWO THOUSAND ONE HUNDRED EIGHTY TWO PESOS AND 95/100 (PHP 121,862,182.95)**, inclusive of taxes, to the said bidder.




