WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Light Craft Landing Station, Port of Benoni, Camiguin, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 01 July 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 87,301,730.51**;

WHEREAS, in response to the said advertisement, only Jejor's Construction Corporation secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 26 July 2023 at 10:00 a.m., the lone bidder, Jejor's Construction Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Jejor's Construction Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 28 July 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 31 July 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Jejor's Construction Corporation;

WHEREAS, Jejor's Construction Corporation was declared as the Single Calculated Bidder in the amount of ₱ 86,932,636.50;

WHEREAS, post-qualification was conducted on 02 to 04 August 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, Jejor's Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 08 August 2023, Jejor's Construction Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **JEJOR'S CONSTRUCTION CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Light Craft Landing Station, Port of Benoni, Camiguin, in the amount of **EIGHTY SIX MILLION NINE HUNDRED THIRTY TWO THOUSAND SIX HUNDRED THIRTY SIX PESOS AND 50/100 (₱ 86,932,636.50)**, inclusive of taxes, to the said bidder.
