**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
PROCUREMENT OF SECURITY SCREENING MACHINE OPERATORS FOR  
PHILIPPINE PORTS AUTHORITY, PORT SECURITY CLUSTERS OF LUZON,  
VISAYAS, NORTHERN MINDANAO AND SOUTHERN MINDANAO COMPRISING  
OF DIFFERENT PORT MANAGEMENT OFFICES AND TERMINAL MANAGEMENT  
OFFICES/PORTS UNDER THEIR RESPECTIVE JURISDICTION**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Screening Machine Operators for Philippine Ports Authority, Port Security Clusters of Luzon, Visayas, Northern Mindanao and Southern Mindanao Comprising of Different Port Management Offices and Terminal Management Offices/Ports Under their Respective Jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 22 July 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 73,902,780.00**;

WHEREAS, during the opening of bids on 15 August 2019 no bidder submitted the bid documents before the deadline prescribed for submission thereof;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Security Screening Machine Operators for Philippine Ports Authority, Port Security Clusters of Luzon, Visayas, Northern Mindanao and Southern Mindanao Comprising of Different Port Management Offices and Terminal Management Offices/Ports Under their Respective Jurisdiction a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Security Screening Machine Operators for Philippine Ports Authority, Port Security Clusters of Luzon, Visayas, Northern Mindanao and Southern Mindanao Comprising of Different Port Management Offices and Terminal Management Offices/Ports Under their Respective Jurisdiction, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
