**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF
PEST CONTROL SERVICES FOR PPA HEAD OFFICE, MOTORPOOL, PPATI,
GAD CENTER AND RECORDS STORAGE FACILITY**
BAC-PGCS-073-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 July 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 2,470,000.00**;

WHEREAS, in response to the said advertisement, only Timber Protection and Maintenance Services, Inc. secured the Bid Documents in the amount of **₱ 5,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 17 August 2021 at 10:00 a.m., the lone bidder, was automatically disqualified for its failure to comply with the required bid submission under Clause 15 of the Bid Data Sheet of the Bidding Documents, which states that "xxx All bid documents shall be book bound, hard bound and properly labelled with index tabs". Timber Protection and Maintenance Services, Inc. submitted its Technical Proposals without index tabs;

WHEREAS, considering that the lone bidder was declared disqualified, the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

WHEREAS, there has been a failure of bidding for the second time, hence a Negotiated Procurement may be resorted to under Section 53.1 of the 2016 Revised IRR of R.A 9184;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A 9184.
2. To resort to Negotiated Procurement (Two-Failed Biddings) under Section 53.1 of the 2016 Revised Implementing Rules and Regulations of R.A 9184.



This has reference to the Opening of Bids for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, held on 17 July 2021, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx"

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 093-2021 Series of 2021, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to resort to Negotiated Procurement (under Two-failed Biddings), as provided for in Section 53.1 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
