**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
SUPPLY, DELIVERY, INSTALLATION AND IMPLEMENTATION OF PORT
PROFILE AND ENGINEERING SYSTEMS (PPES)
BAC-PGCS-056-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Implementation of Port Profile and Engineering Systems (PPES), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 22 July 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 35,000,000.00**;

WHEREAS, in response to the said advertisement, only Mara Linux and Business Solutions Inc. secured and submitted the Bid Documents in the amount of ₱ 25,000.00;

WHEREAS, during the opening of bids on 20 August 2020 at 10:00 a.m., Mara Linux and Business Solutions Inc., the lone bidder, was declared “failed” in the requirements of the First Envelope, for the following reasons:

- Failed to comply with the following as required in Item V. Technical Specifications.
 - a. User Interface
 - b. User Management
 - c. Port Management
- Failed to submit the Service Level Agreement, as required in Item X. Other Requirements.

WHEREAS, Mara Linux and Business Solutions Inc. signified its intention to file a request for reconsideration on their “failed” rating, however, no request for reconsideration was filed within the prescribed deadline for submission thereof;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply, Delivery, Installation and Implementation of Port Profile and Engineering Systems (PPES), a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

“35.1 The BAC shall declare the bidding a failure when:

- b) All prospective bidders are declared ineligible;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply, Delivery, Installation and Implementation of Port Profile and Engineering Systems (PPES), be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.


