**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
SUPPLY AND DELIVERY OF MAINTENANCE SERVICES FOR ENTERPRISE  
STORAGE ARRAY AND RELATED EQUIPMENT  
BAC-PGCS-151-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 13 July 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 3,200,000.00**;

WHEREAS, in response to the said advertisement, only Mara Linux and Business Solutions Inc. secured and submitted the Bid Documents in the amount of ₱ 5,000.00;

WHEREAS, during the opening of bids on 24 August 2020 at 2:00 p.m., Infostorage Corp., the lone bidder, was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Infostorage Corp. was opened and its financial bid was read by the Chairperson, as follows:

1. INFOSTORAGE CORPORATION	₱ 3,200,000.00

WHEREAS, Infostorage Corp. was automatically disqualified for being "non-responsive," for its failure to attach a Schedule of Prices which should be the basis in coming up with the bid offer;

WHEREAS, considering that the lone bidder was automatically disqualified, the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment, a failure pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

“35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
