Award of Contract for the  
**SUPPLY, DELIVERY, AND INSTALLATION OF BAGGAGE X-RAY MACHINES  
AND WALK-THROUGH METAL DETECTORS FOR PORTS AND OFFICES**  
BAC-PGCS-11-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, and Installation of Baggage X-Ray Machines and Walk-Through Metal Detectors for Ports and Offices, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 26 April 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 350,000,000.00**;

WHEREAS, in response to the said advertisement, three (3) bidders secured and submitted the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. Defense and Protection Systems Phils., Inc. (DPSPI)
2. Facilities Protection, Inc. (FPI)
3. Cylix Technologies, Inc./Advance Security and Safety Solutions, Inc./JV

WHEREAS, only two bidders dropped their Technical and Financial Proposals in the bid box before the prescribed deadline for submission of bid documents, namely: Defense and Protection Systems Phils., Inc. and Facilities Protection, Inc. while Cylix Technologies, Inc./Advance Security and Safety Solutions, Inc./JV submitted its letter of withdrawal from participating in the bidding, dated 29 July 2019, and the BAC, finding the reason to be meritorious, accepted their withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 30 July 2019 at 10:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

2. DEFENSE AND PROTECTION SYSTEMS PHILS., INC.	₱ 340,800,000.00

WHEREAS, Bid Evaluation was conducted on 05 August 2019 using non-discretionary criteria, to determine the completeness of the bid and arithmetical corrections;

WHEREAS, the Bid-Evaluation Report, as approved by the BAC on 06 August 2019 showed that both FPI and DPSPi were declared "disqualified" for being non-responsive;

WHEREAS, both FPI and DPSPi filed their respective requests for reconsideration on their "failed" ratings, and the BAC, in a meeting held on 14 August 2019, after due deliberation, denied the request for reconsideration of FPI while the request for reconsideration of DPSPi was granted;

WHEREAS, post-qualification was conducted on 27 August 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by DPSPi and in the Post-Qualification Report, as approved by the BAC on 28 August 2019, DPSPi was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DEFENSE AND PROTECTION SYSTEMS PHILS., INC. (DPSPi)** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery, and Installation of Baggage X-Ray Machines and Walk-Through Metal Detectors for Ports and Offices, in the amount of **THREE HUNDRED FORTY MILLION EIGHT HUNDRED THOUSAND PESOS (₱ 340,800,000.00)**, inclusive of taxes, to the said bidder.
