RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY, DELIVERY AND INSTALLATION OF A CORPORATE ANTI-VIRUS WITH HYBRID NETWORK SUPPORT FOR TWO (2) YEARS AT THE PPA HEAD OFFICE AND PORT MANAGEMENT OFFICES NATIONWIDE

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of a Corporate Anti-Virus with Hybrid Network Support for Two (2) Years at the PPA Head Office and Port Management Offices Nationwide, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 13 July 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P** 2,000,000.00;

WHEREAS, in response to the said advertisement, only American Technologies Inc. secured and submitted the Bid Documents in the amount of # 5,000.00;

WHEREAS, during the opening of bids on 24 August 2020 at 10:00 a.m., American Technologies Inc., the lone bidder, was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of American Technologies Inc. was opened and declared "passing" with the requirements of the Second Envelope and its financial bid was read by the Chairperson, as follows:

WHEREAS, American Technologies Inc. was automatically disqualified for being "non-responsive", for its failure to use the appropriate form as attachment to the Bid Form. The required form to be used as prescribed in the bidding documents should be "For Goods Offered from Abroad" considering that the origin of goods being offered is India, instead of the form "For Goods Offered from within the Philippines," which American Technologies Inc. submitted;

WHEREAS, considering that the lone bidder was automatically disqualified, the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply, Delivery and Installation of a Corporate Anti-Virus with Hybrid Network Support for Two (2) Years at the PPA Head Office and Port Management Offices Nationwide, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- 1. To recommend to the Head of the Procuring Entity that the bidding for the Supply, Delivery and Installation of a Corporate Anti-Virus with Hybrid Network Support for Two (2) Years at the PPA Head Office and Port Management Offices Nationwide, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
