RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ELECTRONIC TERMINAL MANAGEMENT SYSTEM (ETMS) INCLUSIVE OF CLOUD-BASED UNIFIED ELECTRONIC TICKETING CAPABILITIES FOR THE PHILIPPINE PORTS AUTHORITY

BAC-PGCS-011-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of Electronic Terminal Management System (ETMS) Inclusive of Cloud-Based Unified Electronic Ticketing Capabilities for the Philippine Ports Authority, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 07 July 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 500,000,000.00**;

WHEREAS, in response to the said advertisement, only Nextix Inc./ Carus Ferry AB LTD./JV secured the Bid Document in the amount of \$\mathbb{P}\$ 50,000.00 and submitted its Technical and Financial Proposal;

WHEREAS, during the opening of bids on 23 August 2021 at 2:00 p.m., the lone bidder, was declared "failed" with the requirements of the First Envelope considering that the submitted brochures for the Touch Screen, Paper Ticket Printer and Speaker did not indicate any dimension to prove its compliance to the requirements specified in the Terms of Reference (TOR).

WHEREAS, Nextix Inc./ Carus Ferry AB LTD./JV filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 27 August 2021, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply, Delivery, Installation and Commissioning of Electronic Terminal Management System (ETMS) Inclusive of Cloud-Based Unified Electronic Ticketing Capabilities for the Philippine Ports Authority, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

# "35.1 The BAC shall declare the bidding a failure when:

XXX XXX XXX

b) All prospective bidders are declared ineligible;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Supply, Delivery, Installation and Commissioning of Electronic Terminal Management System (ETMS) Inclusive of Cloud-Based Unified Electronic Ticketing Capabilities for the Philippine Ports Authority, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that there was no eligible bidder for the project.
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
