WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 July 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 252,625,710.28**;

WHEREAS, in response to the said advertisement, only DBP Service Corporation secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 25 August 2021 at 10:00 a.m., DBP Service Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of DBP Service Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, post-qualification was conducted on 02 September 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by DBP Service Corporation and in the Post-Qualification Report, as approved by the BAC on 06 September 2021, DBP Service Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DBP SERVICE CORPORATION** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), in the amount of **TWO HUNDRED FIFTY TWO MILLION THREE HUNDRED EIGHTY FOUR THOUSAND ONE HUNDRED THIRTY SIX PESOS AND 56/100 (PHP 252,384,136.56)**, inclusive of taxes, to the said bidder.
