DAVAO, SOCSARGEN, ZAMBOANGA AND ZAMBOANGA DEL NORTE, AND  
TERMINAL MANAGEMENT OFFICES (TMOs)/PORTS UNDER THEIR  
RESPECTIVE JURISDICTION**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster - Southern Mindanao Comprising Port Management Offices (PMOs) Davao, Socsargen, Zamboanga and Zamboanga del Norte, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 June 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 91,234,242.00**;

WHEREAS, in response to the said advertisement, three (3) bidders secured their Bid Documents in the amount of **₱ 50,000.00** and submitted their Technical and Financial Proposals, namely;

1. Sagittarius Security Agency
2. Commander Security Services, Inc.
3. Advance Forces Security & Investigation Services, Inc.

WHEREAS, during the opening of bids on 16 July 2021 at 10:00 a.m., Sagittarius Security Agency was declared "passing" with the requirements of the First Envelope. Commander Security Services, Inc. and Advance Forces Security & Investigation Services, Inc. were declared "failed" for failure to comply with the requirements of the First Envelope (Technical Component);

WHEREAS, Commander Security Services, Inc. and Advance Forces Security and Investigation Services, Inc. signified their intentions to file a request for reconsideration on their "failed" ratings, hence, their unopened Second Envelopes were retained by the BAC, until their requests for reconsideration are resolved by the Committee;

WHEREAS, the Financial Proposal of Sagittarius Security Agency was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, the BAC, in a meeting held on 22 July 2021, after due deliberation and a motion duly made and properly seconded, denied the Request for Reconsideration of Commander Security Services, Inc. while the Request for Reconsideration of Advance Forces Security and Investigation Services, Inc. was granted by the Committee;

WHEREAS, on 30 August 2021 at 11:00 a.m., the Financial Proposal of Advance Forces Security and Investigation Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Sagittarius Security Agency and Advance Forces Security and Investigation Services, Inc. have identical offers;

WHEREAS, Bid Evaluation was conducted on 03 August 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 04 August 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Sagittarius Security Agency and Advance Forces Security and Investigation Services, Inc.;

WHEREAS, both bidders were declared as the Lowest Calculated Bidders in the amount of ₱ 88,011,199.44;

WHEREAS, post-qualification was conducted on 09 August 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by both bidders and in the Post-Qualification Report, as approved by the BAC on 13 August 2021, Sagittarius Security Agency and Advance Forces Security and Investigation Services, Inc. were declared as the Lowest Calculated and Responsive Bidders;

WHEREAS, pursuant to GPPB Circular 06-2005 dated 05 August 2005 on Tie-Breaking Method, the Procuring Entity shall adopt measures determined to be non-discretionary and non-discriminatory based on sheer luck or chance, like "draw lots" or similar methods of chance to break the tie on bidders with identical offers;

WHEREAS, the PPA BAC-PGCS agreed to adopt the use of "draw lots," as tie-breaking method for the two (2) Lowest Calculated and Responsive Bidders, Sagittarius Security Agency and Advance Forces Security and Investigation Services, Inc.;

WHEREAS, both Sagittarius Security Agency and Advance Forces Security and Investigation Services, Inc. signified their "Conforme" on the prescribed rules and regulations on tie-breaking;

WHEREAS, during the conduct of the Tie-Breaking event on 27 August 2021 at 10:00 a.m., Advance Forces Security and Investigation Services, Inc. was declared as the Lowest Calculated and Responsive Bidder in the amount of ₱ 88,011,199.44;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **ADVANCE FORCES SECURITY AND INVESTIGATION SERVICES, INC.** as the Lowest Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster - Southern Mindanao Comprising Port Management Offices (PMOs) Davao, Socsargen, Zamboanga and Zamboanga del Norte, and Terminal Management Offices (TMOs)/Ports under their respective jurisdiction, in the amount of **EIGHTY EIGHT MILLION ELEVEN THOUSAND ONE HUNDRED NINETY NINE PESOS AND 44/100 (PHP 88,011,199.44)**, inclusive of taxes, to the said bidder.



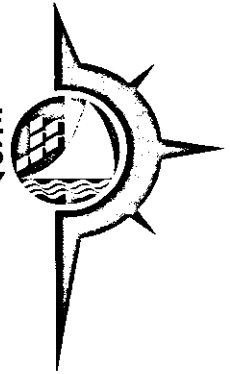
