WHEREAS, during the opening of bids on 27 August 2020 at 10:00 a.m., FMG Refrigeration and Airconditioning Services was declared "passing" with the requirements of the First Envelope. ACMI Office Systems Philippines, Inc. was declared "failed:"

WHEREAS, the Financial Proposal of FMG Refrigeration and Airconditioning Services was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, ACMI Office Systems Philippines, Inc. signified its intention to file a request for reconsideration on their "failed" rating, however, no request for reconsideration was filed within the prescribed deadline for submission thereof;

WHEREAS, Bid Evaluation was conducted on 07 September 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 08 September 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of FMG Refrigeration and Airconditioning Services;

WHEREAS, FMG Refrigeration and Airconditioning Services was declared as the Single Calculated Bidder in the amount of ₽ 10,232,903.94;

WHEREAS, post-qualification was conducted on 11 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by FMG Refrigeration and Airconditioning Services and in the Post-Qualification Report, as approved by the BAC on 16 September 2020, FMG Refrigeration and Airconditioning Services was declared as the Single Calculated and Responsive Bidder;
