SEISMIC ACCELEROGRAPH**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of Seismic Accelerograph, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 22 July 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 75,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Filipinas Tectonic Safety Systems Corporation
2. AF Drill Techniques Instrumentation Corp.

WHEREAS, during the opening of bids on 20 August 2020 at 11:00 a.m., Filipinas Tectonic Safety Systems Corporation was declared "passing" with the requirements of the First Envelope. AF Drill Techniques Instrumentation Corp. was declared "failed;"

WHEREAS, the Financial Proposal of Filipinas Tectonic Safety Systems Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, AF Drill Techniques Instrumentation Corp. filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 27 August 2020, after due deliberation, denied said request for reconsideration;

WHEREAS, Bid Evaluation was conducted on 26 August 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 27 August 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Filipinas Tectonic Safety Systems Corporation;


WHEREAS, Filipinas Tectonic Safety Systems Corporation was declared as the Single Calculated Bidder in the amount of ₱ 74,431,000.08;


WHEREAS, post-qualification was conducted on 03 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Filipinas Tectonic Safety Systems Corporation and in the Post-Qualification Report, as approved by the BAC on 08 September 2020, Filipinas Tectonic Safety Systems Corporation was declared as the Single Calculated and Responsive Bidder;


