WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Body Worn Cameras, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 22 July 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 170,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of \$\mu\$ 50,000.00, namely:

- 1. Contactpoint, Inc.
- 2. Boston Home, Inc.

WHEREAS, during the opening of bids on 20 August 2020 at 2:00 p.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bid were read by the Chairperson, as follows:

2. BOSTON HOME, INC.	₽ 168,800,000.00

WHEREAS, Bid Evaluation was conducted on 25 August 2020 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 27 August 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the (2) bidders;

WHEREAS, no deviations were found in the Technical Proposal of Boston Home, Inc., however, the following deviations were found in the Technical Proposal of Contactpoint, Inc., hence was declared as "failed":

- Body Worn Camera Working temperature submitted is 30°C to 50°C instead of -30°C to +50°C
- The following were not indicated in the brochure:

Docking station must be supplied with a universal power adapter

Evidence Management & Live viewing workstation:

The client/server shall provide the capability to:

- 1. Provide a minimum acceptable video stream quality.
- 2. Configure the quality of a viewed video stream.
- 3. Review full resolution video frames from a recently viewed video stream held in a buffer at the BW site.
- 4. Save video frames locally on their viewing device.
- 5. Provide logging features. System logs shall include as a minimum:
  - a. System access logs
  - b. Video stream access logs
  - Configuration change logs
  - d. Video archive download logs
- 6. Archive video playback over a data link with a throughput of between 9kbps and 2000kbps.

WHEREAS, post-qualification was conducted on 11 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home Inc. and in the Post-Qualification Report, as approved by the BAC on 16 September 2020, Boston Home, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME**, **INC**. as the

Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Body Worn Cameras, in the amount of **ONE HUNDRED SIXTY EIGHT MILLION EIGHT HUNDRED PESOS (PHP 168, 800,000.00)**, inclusive of taxes, to the said bidder.
