WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 16 July 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 17,000,000.00;

WHEREAS, in response to the said advertisement, only Diversified Infrastructure and Architectural Developments Works Corporation secured the Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 30 July 2021, Diversified Infrastructure and Architectural Developments Works Corporation was declared eligible to bid for the project;

WHEREAS, during the opening of the Technical Proposals (First Envelope) conducted on 26 August 2021, Diversified Infrastructure and Architectural Developments Works Corporation passed the requirements of the First Envelope;

WHEREAS, the Technical Proposal of Diversified Infrastructure and Architectural Developments Works Corporation was evaluated using the approved criteria for evaluation to determine its rating, as follows:

1. Experience and Capabilities of Firm	-	15%
2. Plan of Approach and Methodology	-	25%
3. Quality of Personnel	-	60%

and after due deliberation by the BAC, Diversified Infrastructure and Architectural Developments Works Corporation was declared as "passed;"

WHEREAS, the Financial Proposal of Diversified Infrastructure and Architectural Developments Works Corporation was opened on 01 September 2021 and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson;




