WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Administrative Support Manpower Services for PPA Head Office Responsibility Centers and Projects, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 18 July 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 204,232,205.87**;

WHEREAS, in response to the said advertisement, only LBP Service Corporation secured and submitted the Bid Documents in the amount of **₱ 50,000.00**;

WHEREAS, during the opening of bids on 13 August 2019 at 10:00 a.m., LBP Service Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of LBP Service Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 22 August 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 23 August 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of LBP Service Corporation;

WHEREAS, LBP Service Corporation was declared as the Single Calculated Bidder in the amount of ₱ 201,288,731.28, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 03 September 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by LBP Service Corporation and in the Post-Qualification Report, as approved by the BAC on 05 September 2019, LBP Service Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LBP SERVICE CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Administrative Support Manpower Services for PPA Head Office Responsibility Centers and Projects, in the amount of **TWO HUNDRED ONE MILLION TWO HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED THIRTY ONE AND 28/100 PESOS (P 201,288,731.28)**, inclusive of taxes, to the said bidder.
