Award of Contract for the  
**CONSULTANCY SERVICES FOR THE TECHNICAL SERVICES  
FOR THE CONDUCT OF SOIL INVESTIGATION AT  
SELECTED PORTS (PACKAGE 11)**  
*HO-CON-PPDD-23-0002*

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 17 July 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/ advertised is **₱ 31,445,028.05**;

WHEREAS, in response thereto, three (3) consulting firms secured and submitted the Eligibility Documents, namely:

1. R.S. Jardin & Associates
2. Solar Surveying Corporation
3. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV

WHEREAS, after the Eligibility Screening conducted on 27 July 2023, R.S. Jardin & Associates, Solar Surveying Corporation and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared eligible to bid for the project.

WHEREAS, in BAC Resolution No. CON 009-2023 dated 28 July 2023, Recommending Shortlist of Consultants for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), R.S. Jardin & Associates, Solar Surveying Corporation and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared as shortlisted consultants, as approved by the Head of the Procuring Entity (HOPE);

WHEREAS, only two (2) consultants dropped their Technical and Financial Proposals before the deadline for the submission of bid documents on 31 August 2023. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV submitted its letter of withdrawal, dated 30 August 2023, from participating in the bidding, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS during the opening of the Technical Proposals (First Envelope) held on 31 August 2023 at 2:00 p.m., R.S. Jardin & Associates and Solar Surveying Corporation were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Technical Proposals of the two (2) consultants were evaluated using the approved criteria for evaluation to determine their rating, as follows:

and after due deliberation by the BAC, the two (2) consultants were declared as "passed;"

WHEREAS, the Financial Proposals of the two (2) consultants were opened on 11 September 2023 and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson;

WHEREAS, after evaluation of the financial bid and calculation of the final scores, taking into consideration the technical and financial weights, the following rating were arrived at;

WHEREAS, Bid Evaluation was conducted on 13 September 2023 to determine arithmetical or computational errors on the bid proposals of R.S. Jardin & Associates and Solar Surveying Corporation and the Bid Evaluation Report, which was approved by the BAC on 14 September 2023, showed discrepancies on the bid proposal of R.S. Jardin & Associates, as follows:

WHEREAS, R.S. Jardin & Associates was declared as the Highest Rated Bidder in the amount of ₱ 30,685,608.70, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, Post-qualification was conducted on 18 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by R.S. Jardin & Associates and in the Post-Qualification Report, approved by the BAC on 19 September 2023, R.S. Jardin & Associates was declared as the Highest Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **R.S. JARDIN & ASSOCIATES** as the Highest Rated and Responsive Bidder and to recommend the award of contract for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), in the amount of **THIRTY MILLION SIX HUNDRED EIGHTY FIVE THOUSAND SIX HUNDRED EIGHT PESOS AND 70/100 (₱ 30,685,608.70)**, inclusive of taxes, to the said bidder.
