### **RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROVISION AND DELIVERY OF CY 2023 PPA OFFICIAL UNIFORMS ASD-142-2023**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Provision and Delivery of CY 2023 PPA Official Uniforms, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 12 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,596,200.00**;

WHEREAS, in response to the said advertisement, only Del's Apparel Corporation secured the Bid Document in the amount of ₱ 10,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 13 September 2023 at 2:00 p.m., the lone bidder, Del's Apparel Corporation was declared "failed" with the requirements of the First Envelope, for the following reasons:

- a. Submitted Omnibus Sworn Statement failed to state one of the mandatory provisions thereof, and under GPPB Resolution No. 16-2020 "the non-inclusion of the mandatory provisions in any of the required forms shall be a ground for disqualification."
- b. Failed to comply with the Technical Specifications, as follows:
  - i. For Polo Shirt, the color of the outer outline of the DOTr Logo and the half-left side of the globe inside the North Star should be Pantone 286, and the orientation of the Philippine Flag on the left collar should be horizontal/landscape.
  - ii. For Tailor-made Gala uniform, the six (6) boxes in the PPA Logo are not visible on the whole logo structure.

WHEREAS, Del's Apparel Corporation signified no intention to file a request for reconsideration on their "failed" rating, hence, its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, considering that the lone bidder was declared "failed," the BAC declared a failure of bidding, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Provision and Delivery of CY 2023 PPA Official Uniforms, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.



This has reference to the Opening of Bids for the Provision and Delivery of CY 2023 PPA Official Uniforms held on 13 September 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) A prospective bidders are declared ineligible. xxx xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution 069-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
