WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for the Philippine Ports Authority, Port Security Cluster-Visayas Comprising Port Management Offices (PMOs) of Panay/Guimaras, Negros Oriental/Siquijor, Bohol, Negros Occidental/Bacolod/ Banago-Bredco, Eastern Leyte/Samar and Western Leyte/Biliran and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 02 August 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 120,097,074.00**;

WHEREAS, in response to the said advertisement, only Lockheed Global Security and Investigation Services, Inc. secured and submitted the Bid Documents in the amount of ₱ 50,000.00;

WHEREAS, during the opening of bids on 29 August 2019 at 2:00 p.m., Lockheed Global Security and Investigation Services, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Lockheed Global Security and Investigation Services, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 04 September 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 05 September 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Lockheed Global Security and Investigation Services, Inc.;

WHEREAS, Lockheed Global Security and Investigation Services, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 120,095,591.28;

WHEREAS, post-qualification was conducted on 6-11 September 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Lockheed Global Security and Investigation Services, Inc. and in the Post-Qualification Report, as approved by the BAC on 12 September 2019, Lockheed Global Security and Investigation Services, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LOCKHEED GLOBAL SECURITY AND INVESTIGATION SERVICES, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Security Services for the Philippine Ports Authority, Port Security Cluster-Visayas Comprising Port Management Offices (PMOs) of Panay/Guimaras, Negros Oriental/Siquijor, Bohol, Negros Occidental/Bacolod/ Banago-Bredco, Eastern Leyte/Samar and Western Leyte/Biliran and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, in the amount of **ONE HUNDRED TWENTY MILLION NINETY FIVE THOUSAND FIVE HUNDRED NINETY ONE AND 28/100 PESOS (₱ 120,095,591.28)**, inclusive of taxes, to the said bidder.
