RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF CCTV SURVEILLANCE MONITORING FOR NEW SITES FOR PMOS ASD-140-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring for New Sites for PMOs, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 25 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 330,000,000.00**;

WHEREAS, in response to the said advertisement, only Kit Properties Inc./Beyondsight Phils. Inc./Ipointeast Inc./JV secured the Bid Document in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 18 September 2023 at 2:00 p.m., Kit Properties Inc./Beyondsight Phils. Inc./Ipointeast Inc./JV was declared "failed" for failure to comply with the Technical Specifications for the following reasons:

- a. The brochure submitted for the Generator requirement did not specify that it is 230 V and 60 HZ.
- b. The submitted Employer's Certifications for the Supervisors failed to comply with the required minimum experience in supervising multi-site simultaneously and remote video surveillance for ten or more operators at a time.
- c. The submitted Employer's Certificate for Operators failed to comply with the requirement that they have been trained in multi-site at least 20 sites simultaneously.

WHEREAS, Kit Properties Inc./Beyondsight Phils. Inc./Ipointeast Inc./JV signified its intention to file a request for reconsideration on their "failed" rating, hence, the unopened Second Envelopes were retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, Kit Properties Inc./Beyondsight Phils. Inc./Ipointeast Inc./JV submitted an email dated 21 September 2023, informing the BAC that they will no longer file a request for reconsideration;

WHEREAS, considering that the lone bidder was declared "failed," the BAC declared a failure of bidding, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;


xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring for New Sites for PMOs, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring for New Sites for PMOs held on 18 September 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) A prospective bidders are declared ineligible. xxx xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution 072-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
