WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Proposal (RFP) for the Supply and Delivery of Multi-Purpose Vehicles under Negotiated Procurement (Two-Failed Biddings), pursuant to Section 53.1 of the 2016 Revised IRR of RA 9184 and Section V(D) of Annex "H" Consolidated Guidelines for the Alternative Methods of Procurement, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 27 July 2020, continuously for three (3) calendar days;

WHEREAS, the BAC-PGCS likewise invited three (3) suppliers who are technically, legally and financially capable for negotiations to ensure effective competition;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 28,340,000.00**;

WHEREAS, no bidder responded to the required postings while only one (1) bidder, TOYOTA ALABANG, INC. responded to the invitation and submitted its Proposal, together with all the required technical and financial documents;

WHEREAS, during the Negotiation held on 14 August 2020, TOYOTA ALABANG, INC. was given the opportunity to negotiate and discuss the technical and financial requirements of the project to be able to submit a responsive quotation or proposal;

WHEREAS, TOYOTA ALABANG, INC. submitted its best offer based on the final technical and financial requirements, in the amount of P28,340,000.00;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **TOYOTA ALABANG, INC.** as the bidder with the Single Calculated and Responsive Quotation and to recommend the award of contract for the Supply and Delivery of Multi-Purpose Vehicles under Negotiated Procurement (Two-failed Biddings), in the amount of **TWENTY EIGHT MILLION THREE HUNDRED FORTY THOUSAND PESOS (P28,340,000.00)**, inclusive of taxes, to the said bidder.
