**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
SUPPLY AND DELIVERY OF FIFTEEN (15) UNITS MANLIFT  
BAC-PGCS-006-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Fifteen (15) Units Manlift, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 August 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 225,000,000.00**;

WHEREAS, in response to the said advertisement, only BT Industries Inc. secured and submitted the Bid Documents in the amount of **₱ 50,000.00**;

WHEREAS, during the opening of bids on 15 September 2020 at 10:00 a.m., BT Industries Inc., the lone bidder, was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries Inc. was opened and declared "passing" with the requirements of the Second Envelope and its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 21 September 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 22 September 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries Inc.;

WHEREAS, post-qualification was conducted on 23 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries Inc. and in the Post-Qualification Report, as approved by the BAC on 25 September 2020, BT Industries Inc. was declared as "Post-Disqualified" for being non-responsive for failure to comply with the requirement specified in the bidding documents, pursuant to Rule X, Section 34 of the Revised IRR of the Republic Act No. 9184.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of Fifteen (15) Units Manlift, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
