WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Salomague Port Expansion Project, Port of Salomague, Cabugao, Ilocos Sur, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 07 August 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 319,587,126.99**;

WHEREAS, in response to the said advertisement, eight (8) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Goldridge Construction and Development Corporation
2. Marra Builders, Incorporated
3. Sunwest Construction & Development Corporation
4. HG-III Construction & Development Corporation
5. MAC Builders
6. F. Gurrea Construction, Incorporated
7. Equi-Parco Construction Company
8. WTG Construction & Development Corporation

WHEREAS, during the opening of bids on 30 August 2019 at 10:00 a.m., the eight (8) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the eight (8) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 04 September 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 05 September 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of the following bidders;

WHEREAS, despite said discrepancies, the ranking of the eight (8) bidders were not affected, hence Goldridge Const. & Dev't. Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 316,087,000.00, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 9-10 September 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Goldridge Const. & Dev't. Corp. and in the Post-Qualification Report, as approved by the BAC on 12 September 2019, Goldridge Const. & Dev't. Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GOLDRIDGE CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Salomague Port Expansion Project, Port of Salomague, Cabugao, Ilocos Sur, in the amount of **THREE HUNDRED SIXTEEN MILLION EIGHTY SEVEN THOUSAND PESOS (P 316,087,000.00)**, inclusive of taxes, to the said bidder.
