Award of Contract for the
**SAN ANDRES PORT IMPROVEMENT PROJECT, PORT OF SAN ANDRES,
CATANDUANES**
HO-INFRA-PPDD-23-0033

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the San Andres Port Improvement Project, Port of San Andres, Catanduanes, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 18 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 156,980,885.59**;

WHEREAS, in response to the said advertisement, six (6) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

1. Khan Kon Chi Construction and Development Corp.
2. Hi-Tone Construction and Development Corp.
3. Bemkar Consturction and Supply
4. Sunwest, Inc.
5. Luzviminda Engineering
6. MAC Builders

WHEREAS, during the opening of bids on 14 September 2023 at 9:00 a.m., the six (6) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the six (6) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 September 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 September 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Hi-Tone Construction and Development Corp., Sunwest, Inc. and Luzviminda Engineering, as follows;

WHEREAS, Bemkar Construction and Supply was declared as the Lowest Calculated Bidder in the amount of ₱ 155,964,073.50;

WHEREAS, post-qualification was conducted on 21 to 22 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Bemkar Construction and Supply and in the Post-Qualification Report, as approved by the BAC on 26 September 2023, Bemkar Construction and Supply was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **BEMKAR CONSTRUCTION AND SUPPLY** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the San Andres Port Improvement Project, Port of San Andres, Catanduanes. in the amount of **ONE HUNDRED FIFTY FIVE MILLION NINE HUNDRED SIXTY FOUR THOUSAND SEVENTY THREE PESOS AND 50/100 (P 155,964,073.50)**, inclusive of taxes, to the said bidder.
