WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of Body Scanning Machines (Phase IV), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 15 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 90,000,000.00**;

WHEREAS, in response to the said advertisement, only Boston Home Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 05 September 2023 at 2:00 p.m., Boston Home Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Boston Home Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 06 September 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 12 September 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Boston Home Inc.;

WHEREAS, Boston Home Inc. was declared as the Single Calculated Bidder in the amount of ₱ 89,880,000.00;

WHEREAS, post-qualification was conducted on 21 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home Inc. and in the Post-Qualification Report, as approved by the BAC on 25 September 2023, Boston Home Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Installation of Body Scanning Machines (Phase IV), in the amount of **EIGHTY NINE MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS (PHP 89,880,000.00)**, inclusive of taxes, to the said bidder.
