Award of Contract for the
**PROCUREMENT OF ADMINISTRATIVE SUPPORT MANPOWER SERVICES FOR
PPA PORT MANAGEMENT OFFICES (MINDANAO CLUSTER) AND PROJECTS**
BAC-PGCS-195-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices (Mindanao Cluster) and Projects, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 18 July 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 98,203,054.29**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. LBP Service Corporation
2. DBP Service Corporation

WHEREAS, during the opening of bids on 14 August 2019 at 2:00 p.m., both LBP Service Corporation and DBP Service Corporation were declared “passing” with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of both bidders were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, LBP Service Corporation and DBP Service Corporation have identical offers in the amount of ₱ 97,610,532.12;

WHEREAS, Bid Evaluation was conducted on 22 August 2019 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 23 August 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of LBP Service Corporation and DBP Service Corporation;

WHEREAS, both bidders were declared as the Lowest Calculated Bidders in the amount of ₱ 97,610,532.12;

WHEREAS, post-qualification was conducted on 03 September 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by both bidders and in the Post-Qualification Report, as approved by the BAC on 05 September 2019, LBP Service Corporation and DBP Service Corporation were declared as the Lowest Calculated and Responsive Bidders;

WHEREAS, pursuant to GPPB Circular 06-2005 dated 05 August 2005 on Tie-Breaking Method, the Procuring Entity shall adopt measure determined to be non-discretionary and non-discriminatory based on sheer luck or chance, like "draw lots" or similar methods of chance;

WHEREAS, the PPA BAC-PGCS agreed to adopt the use of "draw lots," as tie-breaking method and formulated the rules and regulations in the conduct thereof;

WHEREAS, both LBP Service Corporation and DBP Service Corporation signified their "Conforme" on the prescribed rules and regulations on tie-breaking;

WHEREAS, during the tie-breaking held on 25 September 2019 at 10:00 a.m., LBP Service Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LBP SERVICE CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Administrative Support Manpower Services for PPA Port Management Offices (Mindanao Cluster) and Projects, in the amount of **NINETY SEVEN MILLION SIX HUNDRED TEN THOUSAND FIVE HUNDRED THIRTY TWO AND 12/100 PESOS (₱ 97,610,532.12)**, inclusive of taxes, to the said bidder.
