WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Diaper Changers to Port Areas and Buildings, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 21 August 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 12,000,000.00**;

WHEREAS, in response to the said advertisement, only Boston Home, Incorporated secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 15 September 2020 at 2:00 p.m., Boston Home, Incorporated was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Boston Home, Incorporated was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, post-qualification was conducted on 23 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home, Incorporated and in the Post-Qualification Report, as approved by the BAC on 25 September 2020, Boston Home, Incorporated was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME**, **INCORPORATED** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Diaper Changers to Port Areas and Buildings, in the amount of **ELEVEN MILLION NINE HUNDRED SEVENTY THOUSAND PESOS** (**P** 11,970,000.00), inclusive of taxes, to the said bidder.
