WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Aerial Lidar (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 10 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 24,000,000.00**;

WHEREAS, in response to the said advertisement, only RASA Surveying Instruments secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 12 September 2023 at 2:00 p.m., RASA Surveying Instruments was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of RASA Surveying Instruments was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 September 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 19 September 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of RASA Surveying Instruments;


WHEREAS, RASA Surveying Instruments was declared as the Single Calculated Bidder in the amount of ₱ 23,989,989.00;

WHEREAS, post-qualification was conducted on 27 September 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by RASA Surveying Instruments and in the Post-Qualification Report, as approved by the BAC on 03 October 2023, RASA Surveying Instruments was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **RASA SURVEYING INSTRUMENTS** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Aerial Lidar (Light Detection and Ranging)/Laser Scanner Technology Integrated with Unmanned Aerial Vehicle (UAV), in the amount of **TWENTY THREE MILLION NINE HUNDRED EIGHTY NINE THOUSAND NINE HUNDRED EIGHTY NINE PESOS (PHP 23,989,989.00)**, inclusive of taxes, to the said bidder.
