Award of Contract for the
**SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF CCTV
SURVEILLANCE MONITORING (PHASE II)**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance (Phase II), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 08 August 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 480,000,000.00;

WHEREAS, in response to the said advertisement, only Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 08 September 2020 at 10:00 a.m., Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV was opened, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, however, Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV was declared "failed" with the requirements of the Second Envelope for using the form "For Goods Offered from Philippines" despite its declaration that the origin of goods being offered is China;

WHEREAS, Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV, filed a request for reconsideration on their "failed" rating on 11 September 2020, and the BAC, in a meeting held on 16 September 2020, after due deliberation, granted said request for reconsideration;

WHEREAS, Bid Evaluation was conducted on 21 September 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 22 September 2020, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV, as follows:

WHEREAS, Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV was declared as the Single Calculated Bidder in the amount of ₱ 478,500,000.00;

WHEREAS, post-qualification was conducted on 23 September 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV and in the Post-Qualification Report, as approved by the BAC on 25 September 2020, Kit Properties/Beyondsight Philippines, Inc. and Ipointeast Inc./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KIT PROPERTIES/BEYONDSIGHT PHILIPPINES, INC. AND IPOINTEAST INC./JV** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring (Phase II), in the amount of **FOUR HUNDRED SEVENTY EIGHT MILLION FIVE HUNDRED THOUSAND PESOS (₱ 478,500,000.00)**, inclusive of taxes, to the said bidder.
