NOVELOSO SURVEYING** as the Single Rated and Responsive Proposal and to recommend the Award of Contract for the Consultancy Services for the Hydrographic and Topographic Survey for the Construction of Labason Port, Brgy. Gil Sanchez, Labason, Zamboanga del Norte, in the amount of **TWO HUNDRED FIFTY SEVEN THOUSAND PESOS (₱ 257,000.00)**, inclusive of taxes, to H.O. NOVELOSO SURVEYING.
