WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation, Testing and Commissioning of 28 units Generator Sets for Port Management Offices (PMOs), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 25 August 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 220,000,000.00**;

WHEREAS, in response to the said advertisement, only Jioprovider Corporation/Tres Fratres Power Corporation/JV secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 19 September 2023 at 10:00 a.m., Jioprovider Corporation/Tres Fratres Power Corporation/JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Jioprovider Corporation/Tres Fratres Power Corporation/JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
