WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of Engineering Software (3D Computer-Aided Design (CAD) for PPA Head Office and Port Management Offices Nationwide), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 05 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 70,000,000.00**;

WHEREAS, in response to the said advertisement, only Columbia Technologies, Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 26 September 2023 at 10:00 a.m., Columbia Technologies, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Columbia Technologies, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 27 September 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 03 October 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Columbia Technologies, Inc.;

WHEREAS, Columbia Technologies, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 69,945,000.00;

WHEREAS, post-qualification was conducted on 10 October 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Columbia Technologies, Inc. and in the Post-Qualification Report, as approved by the BAC on 12 October 2023, Columbia Technologies, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **COLUMBIA TECHNOLOGIES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Installation of Engineering Software (3D Computer-Aided Design (CAD) for PPA Head Office and Port Management Offices Nationwide), in the amount of **SIXTY NINE MILLION NINE HUNDRED FORTY FIVE THOUSAND PESOS (PHP 69,945,000.00)**, inclusive of taxes, to the said bidder.
