WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Six (6) Units Multipurpose Vehicle with Hydraulic Crane for Maintenance, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 09 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 45,000,000.00**;

WHEREAS, in response to the said advertisement, only BT Industries, Inc. secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 04 October 2023 at 10:00 a.m., BT Industries, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 05 October 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 10 October 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries, Inc.;

WHEREAS, BT Industries, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 40,668,000.00;

WHEREAS, post-qualification was conducted on 17 October 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries, Inc. and in the Post-Qualification Report, as approved by the BAC on 18 October 2023, BT Industries, Inc. was declared as the Single Calculated and Responsive Bidder;


