RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF SERVICES OF CERTIFYING BODY FOR THE QUALITY MANAGEMENT SYSTEM OF PPA

BAC-PGCS-024-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Services of Certifying Body for the Quality Management System of PPA, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 21 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 3,800,000.00**;

WHEREAS, in response to the said advertisement, only Certification International Philippines, Inc. secured the Bid Document in the amount of \$\mathbb{P}\$ 5,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 13 October 2021 at 10:00 a.m., the lone bidder, was declared "failed" with the requirements of the First Envelope, for failure to submit the Schedule of Requirements Form;

WHEREAS, Certification International Philippines, Inc. filed a request for reconsideration on its "failed" rating, however, the BAC, in a meeting held on 19 October 2021, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Services of Certifying Body for the Quality Management System of PPA, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

XXX XXX XXX

b) All prospective bidders are declared ineligible;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Services of Certifying Body for the Quality Management System of PPA, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, considering that there was no eligible bidder for the project.
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
