RESOLUTION DECLARING FAILURE OF BIDDING FOR THE BUSAY PORT EXPANSION PROJECT, PORT OF BUSAY, BRGY. BUSAY, SACOL ISLAND, ZAMBOANGA CITY PPA-DOTR NO. 002-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Busay Port Expansion Project, Port of Busay, Brgy. Busay, Sacol Island, Zamboanga City (DOTR Project downloaded to PPA for implementation), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 13 September 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 34,525,745.29**;

WHEREAS, no prospective bidders responded to the said Invitation to Bid, nor secured the bid documents;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Busay Port Expansion Project, Port of Busay, Brgy. Busay, Sacol Island, Zamboanga City, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Busay Port Expansion Project, Port of Busay, Brgy. Busay, Sacol Island, Zamboanga City, be declared a “failure” pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.



This has reference to the Bidding for the Busay Port Expansion Project, Port of Busay, Sacol Island, Zamboanga City and Tumulutab Port Expansion Project, Port of Tumulutab, Zamboanga, held on 08 October 2019 at 10:00 a.m. and 2:00 p.m., respectively, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: a) No bids are received. xxx xxx."

In view thereof, we are submitting herewith BAC-EP Resolution Nos. 046-2019 and 047-2019, recommending that the bidding for the Busay Port Expansion Project, Port of Busay, Sacol Island, Zamboanga City and Tumulutab Port Expansion Project, Port of Tumulutab, Zamboanga, be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
