WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Puerto Princesa Port Expansion Project, Port of Puerto Princesa, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 07 August 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 328,754,869.42**;

WHEREAS, in response to the said advertisement, ten (10) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

WHEREAS, during the opening of bids on 02 September 2019 at 10:00 a.m., the ten (10) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the ten (10) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **HG-III CONSTRUCTION & DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Puerto Princesa Port Expansion Project, Port of Puerto Princesa, Palawan, in the amount of **THREE HUNDRED TWENTY SIX MILLION THREE HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED EIGHTY EIGHT AND 53/100 PESOS (₱ 326,388,788.53)**, inclusive of taxes, to the said bidder.
