**SUPPLY AND DELIVERY OF NINETEEN (19) UNITS MULTI-PURPOSE VEHICLE  
WITH HYDRAULIC CRANE FOR MAINTENANCE**  
BAC-PGCS-014-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply And Delivery of Nineteen (19) Units Multi-Purpose Vehicle with Hydraulic Crane for Maintenance, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 08 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 130,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of **₱ 50,000.00** and submitted their Technical and Financial Proposals, namely;

1. BT Industries, Inc.
2. QSJ Motors Phils., Inc.

WHEREAS, during the opening of bids on 30 September 2021 at 2:00 p.m., BT Industries, Inc. was declared "passing" with the requirements of the First Envelope. QSJ Motors Phils., Inc. was declared "failed" for failure to comply with the requirements of the First Envelope (Technical Component);

WHEREAS, QSJ Motors Phils., Inc. signified its intention to file a request for reconsideration on its "failed" rating, hence, the unopened Second Envelopes were retained by the BAC, until the request for reconsideration is resolved by the Committee;

WHEREAS, the Financial Proposal of BT Industries, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, QSJ Motors Phils., Inc. filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 07 October 2021, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, Bid Evaluation was conducted on 07 October 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 31 August 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries, Inc.;

WHEREAS, BT Industries, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 128,782,000.00;

WHEREAS, post-qualification was conducted on 13 October 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries, Inc. and in the Post-Qualification Report, as approved by the BAC on 19 October 2021, BT Industries, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BT INDUSTRIES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply And Delivery of Nineteen (19) Units Multi-Purpose Vehicle with Hydraulic Crane for Maintenance, in the amount of **ONE HUNDRED TWENTY EIGHT MILLION SEVEN HUNDRED EIGHTY TWO THOUSAND PESOS (PHP 128,782,000.00)**, inclusive of taxes, to the said bidder.


