WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Police Safety Equipment and Tactical Gear, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 September 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 40,000,000.00**;

WHEREAS, in response to the said advertisement, only Armscor Shooting Center Inc./Squires Bingham Co. Inc./JV secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 08 October 2020 at 10:00 a.m., Armscor Shooting Center Inc./Squires Bingham Co. Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Armscor Shooting Center Inc./Squires Bingham Co. Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

Inc./JV;

WHEREAS, Armscor Shooting Center Inc./Squires Bingham Co. Inc./JV was declared as the Single Calculated Bidder in the amount of ₱ 30,896,300.00;

WHEREAS, post-qualification was conducted on 16 October 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home, Incorporated and in the Post-Qualification Report, as approved by the BAC on 28 October 2020, Armscor Shooting Center Inc./Squires Bingham Co. Inc./JV was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **ARMSCOR SHOOTING CENTER INC./SQUIRES BINGHAM CO. INC./JV** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Police Safety Equipment and Tactical Gear, in the amount of **THIRTY MILLION EIGHT HUNDRED NINETY SIX THOUSAND THREE HUNDRED PESOS (₱ 30,896,300.00)**, inclusive of taxes, to the said bidder.


