## RESOLUTION DECLARING FAILURE OF BIDDING FOR THE RENOVATION OF AGM-ENGINEERING OFFICE BAC-PGCS-076-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Renovation of AGM-Engineering Office, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 24 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 3,851,728.23**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of \$\bigsip\$ 5,000.00, namely;

- Cytracon Corp.
- CFV ARAR Contractor Phils. Inc.

WHEREAS, only CFV ARAR Contractor Phils. Inc. dropped its Technical and Financial Proposals before the prescribed deadline for submission. Cytracon Corp. submitted its letter of withdrawal from participating in the bidding, dated 15 October 2021, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 19 October 2021 at 2:00 p.m., CFV ARAR Contractor Phils. Inc., was declared "failed" with the requirements of the First Envelope, for failure to submit the Schedule of Requirements Form;

WHEREAS, CFV ARAR Contractor Phils. Inc. filed a request for reconsideration on its "failed" rating, however, the BAC, in a meeting held on 26 October 2021, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, considering that CFV ARAR Contractor Phils. Inc. was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Renovation of AGM-Engineering Office, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

XXX XXX XXX

b) All prospective bidders are declared ineligible;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Renovation of AGM-Engineering Office, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, considering that there was no eligible bidder for the project.
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
