LOT 2: OEM BRANDED DESKTOP COMPUTERS

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Information Technology (IT) Resources Lot 2: OEM Branded Desktop Computers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 09 September 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 20,000,000.00**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of **₱ 25,000.00**, namely:

1. Accent Micro Technologies, Inc.
2. Columbia Technologies, Inc.
3. Dalaz Enterprises

WHEREAS, only two (2) bidders dropped their Technical and Financial Proposals, namely: Columbia Technologies, Inc. and Dalaz Enterprises. Accent Micro Technologies, Inc. did not submit their bid documents nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents;

WHEREAS, during the opening of bids on 07 October 2020 at 10:00 a.m., Columbia Technologies, Inc. was declared "passing" with the requirements of the First Envelope. Dalaz Enterprises was declared "failed" for failure to comply with the weight requirement of not more than 5.5 kg or 12.2 lbs. considering that the brochure submitted for HP ProOne 400 G6 24 All-in-One PC indicated that the weight thereof is "7.75 kg. (Lowest Weight Configuration with adjustable height stand: Weight will vary by configuration)";

WHEREAS, the Financial Proposal of Columbia Technologies, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Dalaz Enterprises filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 14 October 2020, after due deliberation, granted said request for reconsideration;

WHEREAS, on October 16, 2020 at 10:00 a.m., the Financial Proposal of Dalaz Enterprises was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 20 October 2020 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 21 October 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the two (2) bidders;

WHEREAS, Dalaz Enterprises was declared as the Lowest Calculated Bidder in the amount of ₱ 19,400,001.00;

WHEREAS, post-qualification was conducted on 23 October 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Dalaz Enterprises and in the Post-Qualification Report, as approved by the BAC on 28 October 2020, Dalaz Enterprises was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DALAZ ENTERPRISES** as the Lowest Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Information Technology (IT) Resources Lot 2: OEM Branded Desktop Computers, in the amount of **NINETEEN MILLION FOUR HUNDRED THOUSAND ONE PESOS (PHP 19,400,001.00)**, inclusive of taxes, to the said bidder.
