WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Port Police Specific Purpose Motor Vehicles, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 40,000,000.00;

WHEREAS, in response to the said advertisement, only Toyota Alabang, Inc. secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 19 October 2021 at 10:00 a.m., Toyota Alabang, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Toyota Alabang, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 25 October 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 26 October 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Toyota Alabang, Inc.;

WHEREAS, Toyota Alabang, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 38,599,600.00;

WHEREAS, post-qualification was conducted on 28 October 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Toyota Alabang, Inc. and in the Post-Qualification Report, as approved by the BAC on 03 November 2021, Toyota Alabang, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **TOYOTA ALABANG, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Port Police Specific Purpose Motor Vehicles, in the amount of **THIRTY EIGHT MILLION FIVE HUNDRED NINETY NINE THOUSAND SIX HUNDRED PESOS (PHP 38,599,600.00)**, inclusive of taxes, to the said bidder.
