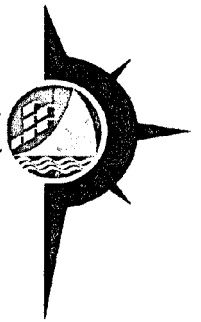

Award of Contract for the  
***DUMAGUIT PORT EXPANSION PROJECT, PORT OF DUMAGUIT,  
NEW WASHINGTON, AKLAN  
HO-INFRA-PPDD-23-0006***

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Dumaguit Port Expansion Project, Port of Dumaguit, New Washington, Aklan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 20 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 189,951,855.68**;

WHEREAS, in response to the said advertisement, nine (9) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

1. Khan Kon Chi Construction and Development Corporation
2. Hi-Tone Construction and Development Corporation
3. Sunwest, Inc.
4. Luzviminda Engineering
5. MAC Builders
6. MRBII Construction Corporation
7. WTG Construction and Development Corporation
8. IBC International Builders Corporation
9. F. Gurrea Construction Inc.

WHEREAS, during the opening of bids on 11 October 2023 at 2:00 p.m., only seven (7) bidders were declared "passing" with the requirements of the First Envelope, namely: Hi-Tone Construction and Development Corp., Khan Kon Chi Construction and Development Corp., Sunwest, Inc., Luzviminda Engineering, MAC Builders, MRBII Construction Corp. and WTG Construction and Development Corp.. F. Gurrea Construction Inc. and IBC International Builders Corp. were declared "failed" with the requirements of the First Envelope;

WHEREAS, F. Gurrea Construction Inc. was declared “failed” since the pledged two (2) units Concrete Vibrator with a capacity of 3.5 hp are not under the name of the company but in the name of a certain F. Gurrea. IBC International Builders Corp. failed to submit the required supporting documents for the Single Largest Completed Contract, which should be supported by a Notice of Award, Notice to Proceed and Contracts, among others, as stated in the footnote of the bid forms. Further, the pledged one (1) unit 60T Crawler Crane has attached Sales Contract which is conditional in nature considering that the equipment shall only be transferred to the Buyer upon completion of the full payment. No document was attached to prove that the said condition was fulfilled to effect the transfer of the pledged equipment to the bidder;

WHEREAS, IBC International Builders Corp. signified no intention to file their request for reconsideration on their “failed” rating, hence, their Second Envelope was returned unopened and duly received by their authorized representatives. F. Gurrea Construction Inc. signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration have been resolved by the Committee;

WHEREAS, the Financial Proposals of the seven (7) bidders were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, F. Gurrea Construction Inc. did not file a request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, Bid Evaluation was conducted on 16 October 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 17 October 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corp., Hi-Tone Construction and Development Corp., Sunwest, Inc. and Luzviminda Engineering, as follows;



WHEREAS, MRBII Construction Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 188,939,341.69;

WHEREAS, post-qualification was conducted on 22 & 21 October 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by MRBII Construction Corp. and in the Post-Qualification Report, as approved by the BAC on 26 October 2023, MRBII Construction Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MRBII CONSTRUCTION CORP.** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Dumaguít Port Expansion Project, Port of Dumaguít, New Washington, Aklan, in the amount of **ONE HUNDRED EIGHTY EIGHT MILLION NINE HUNDRED THIRTY NINE THOUSAND THREE HUNDRED FORTY ONE PESOS AND 69/100 (₱ 188,939,341.69)**, inclusive of taxes, to the said bidder.

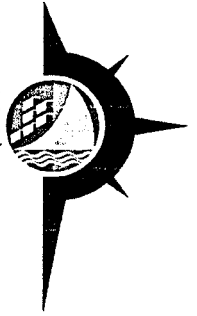
