**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF SECURITY SERVICES FOR PHILIPPINE PORTS
AUTHORITY, PORT SECURITY CLUSTER-NORTHERN MINDANAO
COMPRISING PORT MANAGEMENT OFFICES (PMOs) OF MISAMIS
ORIENTAL/CAGAYAN DE ORO, LANA DEL NORTE/ILIGAN, MISAMIS
OCCIDENTAL/OZAMIZ, AGUSAN, SURIGAO AND TERMINAL
MANAGEMENT OFFICES (TMOs)/PORTS UNDER THEIR
RESPECTIVE JURISDICTION

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Northern Mindanao Comprising Port Management Offices (PMOs) of Misamis Oriental/Cagayan de Oro, Lanao del Norte/Iligan, Misamis Occidental/Ozamiz, Agusan, Surigao and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 09 October 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 106,125,456.00**;

WHEREAS, in response to the said advertisement, only Sagittarius Security Agency secured and submitted the Bid Documents in the amount of **₱ 50,000.00**;

WHEREAS, during the opening of bids on 06 November 2019 at 10:00 a.m., Sagittarius Security Agency, the lone bidder, was declared "failed" in the requirements of the First Envelope, for submitting an altered form for the Bid Securing Declaration;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Northern Mindanao Comprising Port Management Offices (PMOs) of Misamis Oriental/Cagayan de Oro, Lanao del Norte/Iligan, Misamis Occidental/Ozamiz, Agusan, Surigao and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

- b) All prospective bidders are declared ineligible;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Northern Mindanao Comprising Port Management Offices (PMOs) of Misamis Oriental/Cagayan de Oro, Lanao del Norte/Iligan, Misamis Occidental/Ozamiz, Agusan, Surigao and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Northern Mindanao Comprising Port Management Offices (PMOs) of Misamis Oriental/Cagayan de Oro, Lanao del Norte/Iligan, Misamis Occidental/Ozamiz, Agusan, Surigao and Terminal Management Offices (TMOs)/Ports Under Their Respective Jurisdiction, held on 06 November 2019 at 10:00 a.m., which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-EP Resolution No. 134-2019, recommending that the bidding for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Northern Mindanao Comprising Port Management Offices (PMOs) of Misamis Oriental/Cagayan de Oro, Lanao del Norte/Iligan, Misamis Occidental/Ozamiz, Agusan, Surigao and Terminal Management Offices (TMOs)/Ports Under Their Respective Jurisdiction, be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
